BE IT ENACTED by the Parliament of the Commonwealth of Dominica as follows:—

## 1991/92 APPROPRIATION ACT, 1991.

2. The issue from the Consolidated Fund of the sum of two Appropriation hundred and nine million, seven hundred ten thousand, one hundred sixty dollars (\$209,710,160) is hereby authorised for meeting expendture for services for the year ending on the 30th June, 1992 under the Schedule hereto, and the sum specified in the said Schedule appointed out of the said sum of two hundred and nine million seven hundred ten thousand, one hundred sixty dollars for the purposes specified in relation to that Head in the Estimates for the said year.
