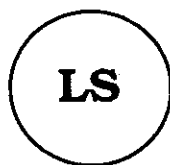

AN ACT TO PROVIDE FOR THE SERVICES OF THE COMMONWEALTH OF DOMINICA FOR THE YEAR ENDING ON THE 30TH DAY OF JUNE, 1993.

(Gazetted 23rd July, 1992)

BE IT ENACTED by the Parliament of the Commonwealth of Dominica as follows:

1. This Act may be cited as the –

**1992/93 APPROPRIATION ACT, 1992.**

2. The issue from the Consolidated Fund of the sum of two hundred and nine million, three hundred fifty-seven thousand, four

hundred forty dollars (\$209,357,440) is hereby authorised for meeting expenditure for services for the year ending on the 30th June, 1993 under the Schedule hereto, and the sum specified in the said Schedule appointed out of the said sum of two hundred and nine million, three hundred fifty-seven thousand, four hundred forty dollars for the purposes specified in relation to that Head in the Estimates for the said year.

Payment from the  
Consolidated Fund.

3. The Accountant General is hereby authorised and required from time to time upon Warrant of the Minister for Finance to pay out of the Consolidated Fund in respect of the several services specified in the said Schedule the several monies hereby appropriated in such manner as the said Warrant shall direct without further order or formality.

Commencement.

4. This Act shall come into operation on the 1st day of July, 1992.
