AN ACT TO PROVIDE FOR THE SERVICES OF THE COM-MONWEALTH OF DOMINICA FOR THE YEAR ENDING ON THE 30TH DAY OF JUNE, 1994.

(Gazetted 1st July, 1993.)

BE IT ENACTED by the Parliament of the Commonwealth of Dominica as follows:

1. This Act may be cited as the -

Short title.

1993/94 APPROPRIATION ACT 1993.

2. The issue from the Consolidated Fund of the sum of two Appropriation hundred twenty-five million, nine hundred and eight thousand and

forty dollars (\$225,908,040) is hereby authorised for meeting expenditure for services for the year ending 30th June, 1994 under the Schedule hereto, and the sum specified in the said Schedule appointed out of the said sum of two hundred twenty-five million. nine hundred and eight thousand and forty dollars for the purposes specified in relation to the Head in the Estimates for the said year.

Payment from the Consolidated Fund.

3. The Accountant General is hereby authorised and required from time to time upon Warrant of the Minister of Finance to pay out of the Consolidated Fund in respect of the several services specified in the said Schedule the several monies hereby appropriated in such manner as the said Warrant shall direct without further order or formality.

Commencement.

4. This Act shall come into operation on the 1st day of July, 1993.
