

AN ACT TO PROVIDE FOR THE SERVICES OF THE COMMONWEALTH OF DOMINICA FOR THE YEAR ENDING ON THE THIRTIETH DAY OF JUNE, 1995.

(Gazetted 21st July, 1994.)

BE IT ENACTED by the Parliament of the Commonwealth of Dominica as follows:

1. This Act may be cited as the -

Short title.

1994/95 APPROPRIATION ACT 1994.

2. The issue from the Consolidated Fund of the sum of two Appropriation hundred seventy-eight million, eight hundred and two thousand, (\$278,802,420.00).

four hundred and twenty dollars (\$278,802,420.00) is hereby authorised for meeting expenditure for services for the year ending 30th June, 1995, under the Schedule hereto, and the sum specified in the said Schedule appointed out of the said sum of two hundred seventy-eight million, eight hundred and two thousand, four hundred and twenty dollars for the purposes specified in relation to the Head in the Estimates for the said year.

Payment from the Consolidated Fund.

3. The Accountant General is hereby authorised and required from time to time upon Warrant of the Minister for Finance to pay out of the Consolidated Fund in respect of the several services specified in the said Schedule the several monies hereby appropriated in such manner as the said Warrant shall direct without further order or formality.

Commencement.

4. This Act shall come into operation on the 1st day of July, 1994.
