**AN ACT TO PROVIDE FOR THE SERVICES OF THE
COMMONWEALTH OF DOMINICA FOR THE
YEAR ENDING ON THE THIRTIETH DAY OF
JUNE 2008.**

(Gazetted 30th August, 2007).

BE IT ENACTED by the Parliament of the Commonwealth of
Dominica as follows:

1. This Act may be cited as the -

Short title.

2007/2008 APPROPRIATION ACT 2007.

Appropriation.

2. The issue from the Consolidated Fund of the sum of three hundred and forty-two million, six hundred and nineteen thousand, five hundred and one dollars (\$342,619,501) is hereby authorised for meeting the expenditure for services for the year ending 30th June, 2008 under the Heads of Expenditure specified hereto, and the sum specified in the said Schedule opposite to the Head is hereby appropriated out of the said sum for the purposes specified in relation to the Head in the Estimates for the said year.

Schedule.

Payment from the
Consolidated Fund.

3. The Accountant General, is hereby authorised and required from time to time upon warrant of the Minister for Finance, to pay out of the Consolidated Fund in respect of the several services specified in the said Schedule, the several monies hereby appropriated in such manner as the said warrant shall direct without further order or formality.

Schedule.

Commencement.

4. This Act shall be deemed to have come into force on the 1st day of July, 2007.
